C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: SRPW 3 and SRPW 7 are seasonal RPWs that are found in the northern portion of the site. They flow directly into PRPW 4. They appear to be straight. These SRPWs are performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. The SRPWs provide breeding grounds for aquatic species in the area and provides habitat for wildlife in the area. These SRPWs help to filter run-off and pollutants from the nearby roads and industrial development before they travel downstream to the TNW. These SRPWs also help to store flood water during the wetter months and after heavy rains. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW, it has been determined that there is a significant nexus between the SRPWs and the downstream TNW.
