If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**Wetland boundaries established by the 1987 Wetland Delineation Manual. The wetlands (Wetland 1 / 2.69 + Wetland 2 / 0.24) = 2.93 acres) demonstrated the appropriate hydrology, hydrophytic vegetation, and hydric soils to classify it as a wetland. The wetlands in the review area are part of a large wetland system that continues offsite, eventually bisected by the OHMW of Cedar Creek, (a named perennial RPW) prior to discharging into the Atlantic Intracoastal Waterway AIWW (TNW). The RPW is represented by a blue line on the USGS topographic map which is the symbol for a perennial flow and has a clearly defined channel with bed and banks, evident from aerial photography. A review of USGS topographic maps, Horry County Soil Survey publications, and aerial photography concur with the conclusion that the tributary is perennial, flowing at least 95% of the year. The offsite named perennial RPW (Cedar Creek) discharges directly into the AIWW, a named TNW.**
