Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project area is 2.8 acres in size and consists of an existing stormwater pond and portions of two linear conveyances (top of bank to top of bank) that exit the stormwater pond.

The stormwater pond was excavated from uplands and was permitted by the SCDHEC-EQC, Bureau of Water, Storm Water Division as a stormwater pond (Permit #-SCR10E906). This pond was excavated from uplands and is grassed. This pond receives stormwater from the surrounding uplands. For these reasons, the pond was determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.

Linear conveyance A is 5.5 feet wide, 2.5 feet deep, and 280 feet long and contains weedy vegetation. There was no water flow in conveyance A. Linear conveyance B is 7.3 feet wide, 3.6 feet deep, and 675 feet long and is grassed. There was some ponded water but no flow in conveyance B. Both of the linear conveyances were excavated from uplands and only drain overflow from the non-jurisdictional stormwater pond and the surrounding uplands. For these reasons linear conveyance A and linear conveyance B were determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
