The project area consists of 0.51 acres in the shoulder and right-of-way of Coreys Court in Dillon County, SC. USGS topographic survey information depicts a cleared area that is void of any blue line features or wetland symbols. NWI maps show the project area as upland cropland/pasture. The entire project area is comprised of the non-hydric soil Dothan Loamy fine sand. Based on a combination of the above listed resources and previous determination SAC-2009-00627, the project was determined to be void of aquatic resources.
