C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The project area is comprised of approximately 66 acres of which 32 acres have been identified as freshwater wetlands. The forested freshwater wetlands located within the project area have been determined to be completely surrounded by non-hydric soils and no surface or shallow subsurface connection to any water of the U.S. (WOUS) was evident during the site visit or could be found after review of aerial photography, soil survey information, NWI maps, LIDAR maps and topographic maps. Each of these depressional wetlands exhibited hydric soils, hydrophitic vegetation, and sufficient indicators of hydrology to satisfy the criteria set forth in the 1987 Wetland Delineation Manual. However, all water located within or draining toward this wetland has no discernible or traceable outfall or connection to any waters of the United States. Additionally, the wetland system in review was found to be surrounded completely by forested uplands, and upland development (residential subdivisions and Highways) further disrupting possible connections to any WOUS. Chemically, the wetlands do not affect any WOUS in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of the wetlands and their relation to other WOUS is such that water in this wetland is retained and eventually percolates through the soil to groundwater only, to an unknown depth, providing little if any stormwater attenuation. Biologically, these wetlands are not essential in providing organic carbons in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical, physical or biological connection, this wetland system has been determined to be isolated, non-jurisdictional.

During a previous site visit of July 3, 2013, documented under SAC 2008-01855-3H, letter dated July 24, 2013 the following data was collected for the site: For the time period of July 1 – 7, 2013 the North Myrtle Beach area weather station received 2.3 inches of rainfall. For the previous three months of April, May and June, the North Myrtle Beach weather station has recorded a total of 19.2 inches. The North Myrtle Beach Weather station is approximately 5 miles from the project area. This area as well as most of the Coastal Region of South Carolina is receiving above normal rainfall amounts for the year (2013).

Review of all current desktop resources to include lidar, and Google 2017 aerial photos and the applicant's submittal revealed that site conditions have not changed from the previous 2013 Site visits to the surrounding area; therefore, a site visit was not warranted for this determination.
