Wetland B is 0.435 acres in size and is located on the western portion of the project area along a powerline ROW. It consists of a concave, depressional gum pond and is surrounded by upland areas. It receives runoff from these surrounding uplands, but its only outlet is through evapotranspiration. It does not have an apparent surface or subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the U.S. Wetland B also has no apparent connection to interstate or foreign commerce. Therefore, Wetland B was determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland listed in Section I.B.1.b all meets the three parameters of a wetland. The wetland feature listed in Section I.B.1.b above is part of a larger contiguous wetland system that is directly abutting Popperdam Creek, the perennial tributary described in Section III.D.2. The aforementioned wetland feature has a contiguous surface water connection to the larger wetland system that also abuts Popperdam Creek. The off-site, named tributary, Popperdam Creek, appears to exhibit perennial flow, as a defined flow channel and bed and bank can be observed from a 2017 Google Earth aerial image. In addition, it appears that this tributary drains an approximately 1.3 square mile area, obtaining hydrological inputs from surrounding wetlands within the approximate drainage area, as well as from upland runoff also in the drainage area. Popperdam Creek serves as the headwater system for McChune Branch, another offsite perennial tributary. McChune Branch flows for 5 miles, where it then discharges into Goose Creek Reservoir, a TNW. Therefore, it was determined that the wetland listed above in Section I.B.1.b is jurisdictional under Section 404 of the CWA. Information regarding aquatic features determined to be non-jurisdictional under Section 404 of the CWA can be found within JD Form 1 of 2 for this project.
