property were assessed under normal climatic conditions as potential wetlands and determined to be uplands. The remaining 0.28 acres were previously determined to be wetlands in a Jurisdictional Determination issued by the Corps on December 20, 2017. However, after further review and field observations, the remaining 0.28 acres were determined to be lacking parameters to meet the criteria of a wetland in accordance with the 1987 Wetland Delineation Manual. Specifically, Data Point 1 and 2 were lacking hydrology indicators and hydric soils. Data Point 4 exhibited hydrophytic vegetation and hydric soil, however, indicators of hydrology were absent. This JD will supercede the jurisdictional determination issued on December 20, 2017.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form assesses a 0.48 acre site consisting of 0.20 acre of jurisdictional freshwater wetlands adjacent to the Waccamaw River (TNW). The wetland onsite exhibited all three parameters set forth in the 1987 Corps Delineation Manual. The soils observed within the wetland met the criteria for a Depleted Matrix (F3) Hydric Soil Indicator (See Data Sheet 3 in file). The wetland exhibited hydrology indicators including water marks on the trees, oxidized rhizospheres along living root channels, water-stained leaves, inundation visible on aerial imagery, and geomorphic position. The vegetation within the wetland was also determined to be hydrophitic. The vegetation was >50% for the Dominance Test.

In addition, the remaining 0.28 acres of the subject property were assessed under normal climatic conditions as potential wetlands and determined to be uplands. The remaining 0.28 acres were previously determined to be wetlands in a Jurisdictional Determination issued by the Corps on December 20, 2017. However, after further review and field observations, the remaining 0.28 acres were determined to be lacking parameters to meet the criteria of a wetland in accordance with the 1987 Wetland Delineation Manual. Specifically, Data Point 1 and 2 were lacking hydrology indicators and hydric soils. Data Point 4 exhibited hydrophitic vegetation and hydric soil, however, indicators of hydrology were absent. This JD will supercede the jurisdictional determination issued on December 20, 2017.

Furthermore, a previous enforcement case (SAC# 2004-05378, C&D issued 10/21/2004) occurred on the adjacent site (Lot 1 Waccamaw Circle), which was determined to consist entirely of wetlands. Lot 1 has the same geomorphic positioning as the subject property (Lot 2), however Lot 1 is presently at a higher grade than Lot 2 due to the placement of unauthorized fill material.
