The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: **The wetlands evaluated in this SND are performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. Wetland B is directly abutting Seasonal Tributary Stream A. Wetland D is directly abutting Seasonal Tributary Stream C. A variety of biological functions are being performed by the wetlands. The wetlands provide possible breeding grounds for aquatic species as well as habitat for wildlife in the area. The chemical functions include nutrient and waste filtration for the surrounding forested, agricultural, and industrial areas. The physical functions of the wetland include flow maintenance by retaining runoff and storm water during times of heavy rain and during the wetter months.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: Streams A and C are located along the eastern property boundary are performing a variety of functions that related to the physical, chemical, and biological integrity of the TNW. The physical characteristics of the tributaries include performing flow maintenance functions such as retaining runoff from the adjacent agricultural fields. Flow maintenance results in the reduction of downstream peak flows, which help to maintain seasonal flow volumes. Functions of the tributaries that impact the chemical integrity of the TNW downstream include the filtering of excess nutrients contributed by runoff from the surrounding uplands due to agricultural practices, which reduces nitrogen and phosphorus loading downstream. A variety of biological functions are**

being performed by the seasonal RPWs, which include providing breeding grounds and shelter for aquatic wildlife and foraging areas for water dependent species and other wildlife. These tributaries provide diversity through vegetation changes, and where the aquatic system adjoins the adjacent uplands.

The wetlands evaluated in this SND are performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. Wetland B is directly abutting Seasonal Tributary Stream A. Wetland D is directly abutting Seasonal Tributary Stream C. A variety of biological functions are being performed by the wetlands. The wetlands provide possible breeding grounds for aquatic species as well as habitat for wildlife in the area. The chemical functions include nutrient and waste filtration for the surrounding forested, agricultural, and industrial areas. The physical functions of the wetland include flow maintenance by retaining runoff and storm water during times of heavy rain and during the wetter months.

Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable water of the Thicketty Creek, it has been determined that there is a significant nexus between the relevant reach of the tributaries and their abutting wetlands to the downstream TNW.
