C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review is comprised of 0.28 acres and contained no Waters of the U.S. (WOUS). This site is comprised of hydric soils (Leon and Witherbee). Wetland hydrology (inundation) was present within the boundaries of the wetland (0.03 acres). Horry county NWI data depict the site as uplands (U17). The isolated wetlands are approximately 1800 linear feet from the nearest WOUS (unnamed perennial RPW) feature as depicted on USGS topographic maps and Google earth true color aerial imagery.

The isolated wetland has no connections to other Waters of the US (WOUS). Additionally, the site contains a single upland excavated non-jurisdictional ditch separated by the isolated wetland by a earthen berm. Field inspection of the perimeter of the wetland and berm yielded no visible connection. The wetland and ditch are located west of a unland excavated pond centrally located within the development. This development was constructed in uplands uphill of wetlands documented under SAC-2017-01302. The site and surrounding uplands are located atop a topographic change, higher in elevation than the nearby wetlands to the west.

This site was assessed on a single basis form..
