- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: **The two features in the review area consist of an abandoned quarry and stormwater pond totaling 8.013 acres. Pond 1 is 7.511 acres and Pond 2 is 0.502 acres. These features were constructed as part of historic mining operations on the site. Based on review of USGS, NWI, historic aerial imagery, soil data, and a site visit on 1/11/18, both features appear to have been excavated out of upland. They receive runoff from adjacent upland areas, and the only outlet is**

through evapotranspiration. Neither has an outfall to other tributaries or waters of the U.S. and no apparent surface or shallow subsurface hydrologic connection or ecological connectivity exists with other waters of the U.S. It was therefore determined that both features are upland-dug and are not jurisdictional under Section 404 of the CWA. Within the project area of this jurisdictional determination, besides these two upland-dug ponds, the project area consists entirely of uplands.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The two features in the review area consist of an abandoned quarry and stormwater pond totaling 8.013 acres. Pond 1 is 7.511 acres and Pond 2 is 0.502 acres. These features were constructed as part of historic mining operations on the site. Based on review of USGS, NWI, historic aerial imagery, soil data, and a site visit on 1/11/18, both features appear to have been excavated out of upland. They receive runoff from adjacent upland areas, and the only outlet is through evapotranspiration. Neither has an outfall to other tributaries or waters of the U.S. and no apparent surface or shallow subsurface hydrologic connection or ecological connectivity exists with other waters of the U.S. It was therefore determined that both features are upland-dug and are not jurisdictional under Section 404 of the CWA. Within the project area of this jurisdictional determination, besides these two upland-dug ponds, the project area consists entirely of uplands.
