C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

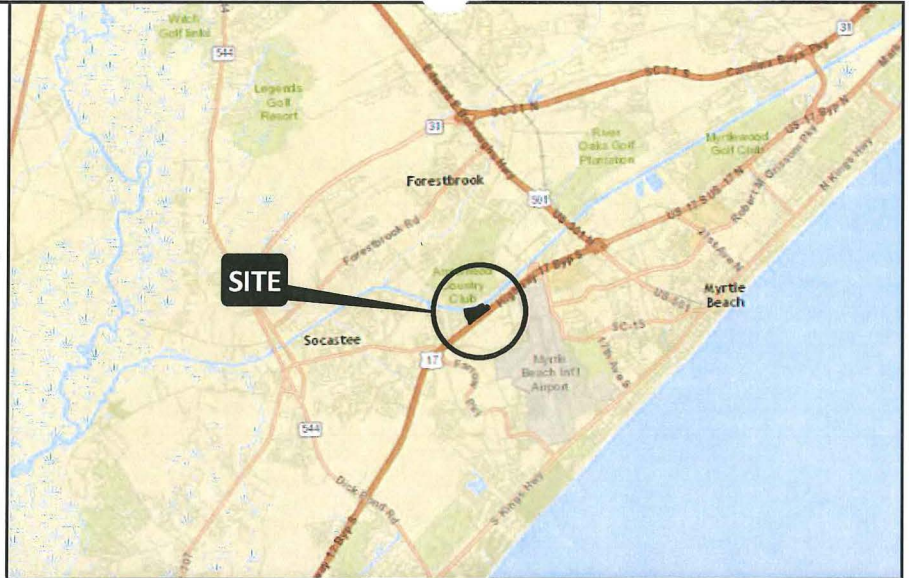



B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 40.56 acres situated between U.S. Highway 17 Bypass and the AIWW. Located within the project area are 12.21 Acres of freshwater wetlands and 1,904 linear feet of TNW (AIWW). In addition, the property boundary extends past the MHW of the AIWW in some locations and includes 1.2 acres of open tidal waters of the AIWW. Located onsite are 3 upland excavated stormwater detention ponds. These ponds are determined to have been excavated from uplands and therefore are not impoundments of any waters of the United States. .
