### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form documents one perennial tributary. PRPW Tributary 1 has a continuous OHWM, flocculent from iron oxidizing bacteria, and was flowing at the time of the site visit, and has a drainage area of approximately 80 acres, which is large enough to support a perennial flow regime. Based upon these factors, this tributary has been determined to flow perennially. Additionally, a small drainage area was investigated as a potential tributary. It had no OHWM or other indicators of a tributary. Therefore, the Corps determined that it is not a tributary. Another area noted on the NWI as a potential wetland area was investigated and found to have upland soils and thus to be an upland area. Neither of these potential features were determined to be waters of any kind and are upland features. Per guidance from RGL 07-01, perennially flowing tributaries are jurisdictional. As such, all waters documented on this form are jurisdictional.
