appears dug in uplands and drains uplands. The conveyance were heavily channelized. This linear feature was dry at the time of survey and did not exhibit tributary features such as an ordinary high water mark. Therefore, this linear feature is non jurisdictional and not subject to Corps regulatory authority under the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** There are two separate JDs because the site is non contiguous. A separate JD (SAC 2015-00814) was issued for the area known as Daniels Orchard POA. This area is shown on the plat, but is covered under a separate JD. No wetlands or other waters of the United States were found for this parcel. Therefore, the 1.96 acre tract of land is not subject to Corps regulatory authority under Clean Water Act Section 404 or Section 10 of the Rivers and Harbors Act.
