C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

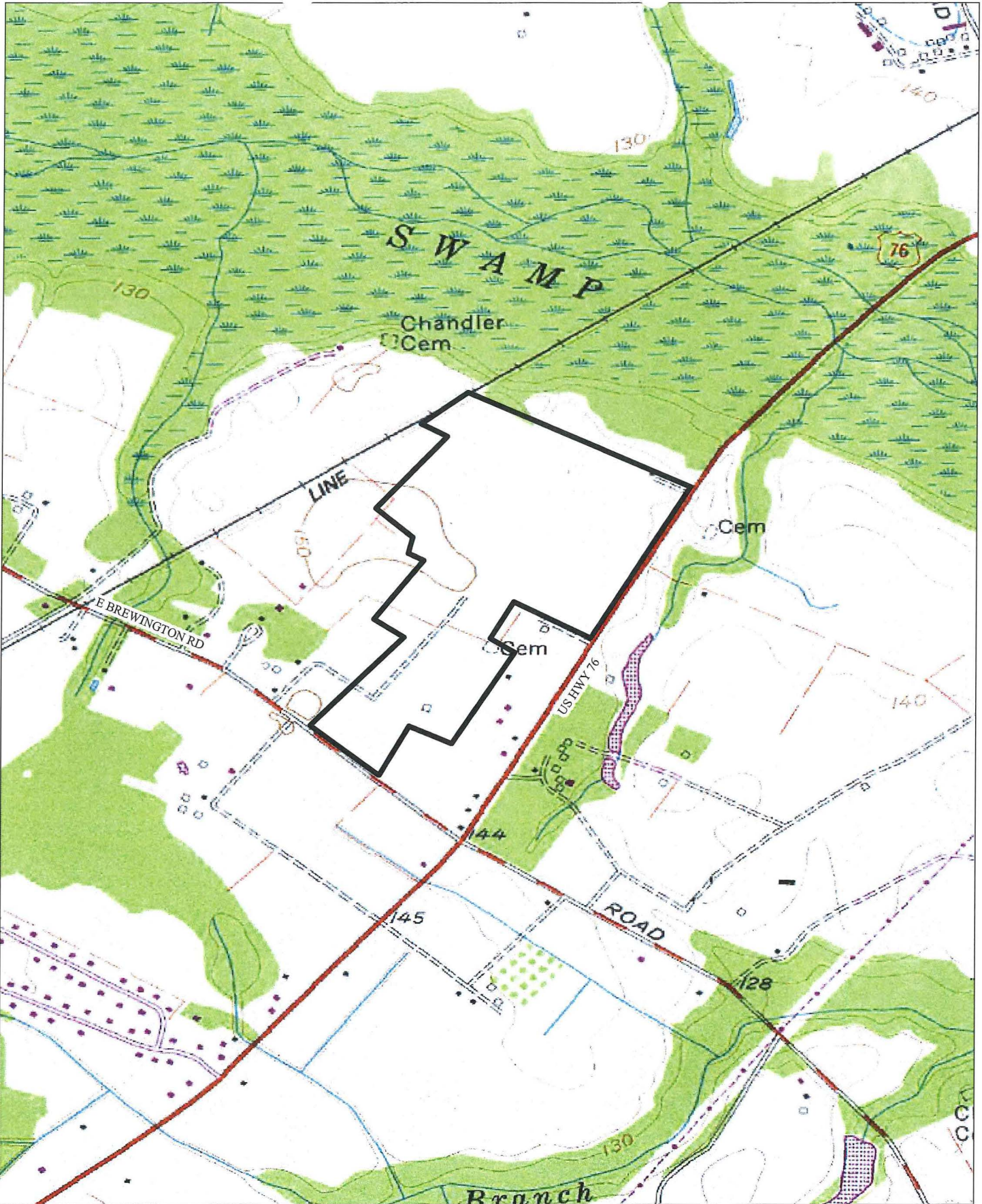

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 112.81 acre tract that is determined to consist entirely of uplands. The project area currently consist of planted soy beans fields. Arial photographs dating back to 1974 depict the project area as cropland and agricultural fields. USGS topographic survey information depicts the project area as cleared uplands that do not contain any blue line features or other symbols that would typically represent a WOUS. Sumter County LiDAR reveals that there are no linear features within the landscape. NWIs depict the site as agricultural uplands and site photos and data sheets submitted by Sabine & Waters, Inc. depict the project area as upland agricultural fields planted with soybeans that contain soils with high chroma and value, and lack any indicators of hydrology. Due to the consistent depiction of uplands throughout the NWIs, USGS topo maps, aerial photographs, data sheets and site photos , the tract is determined to consist entirely of uplands..

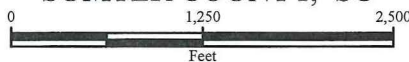

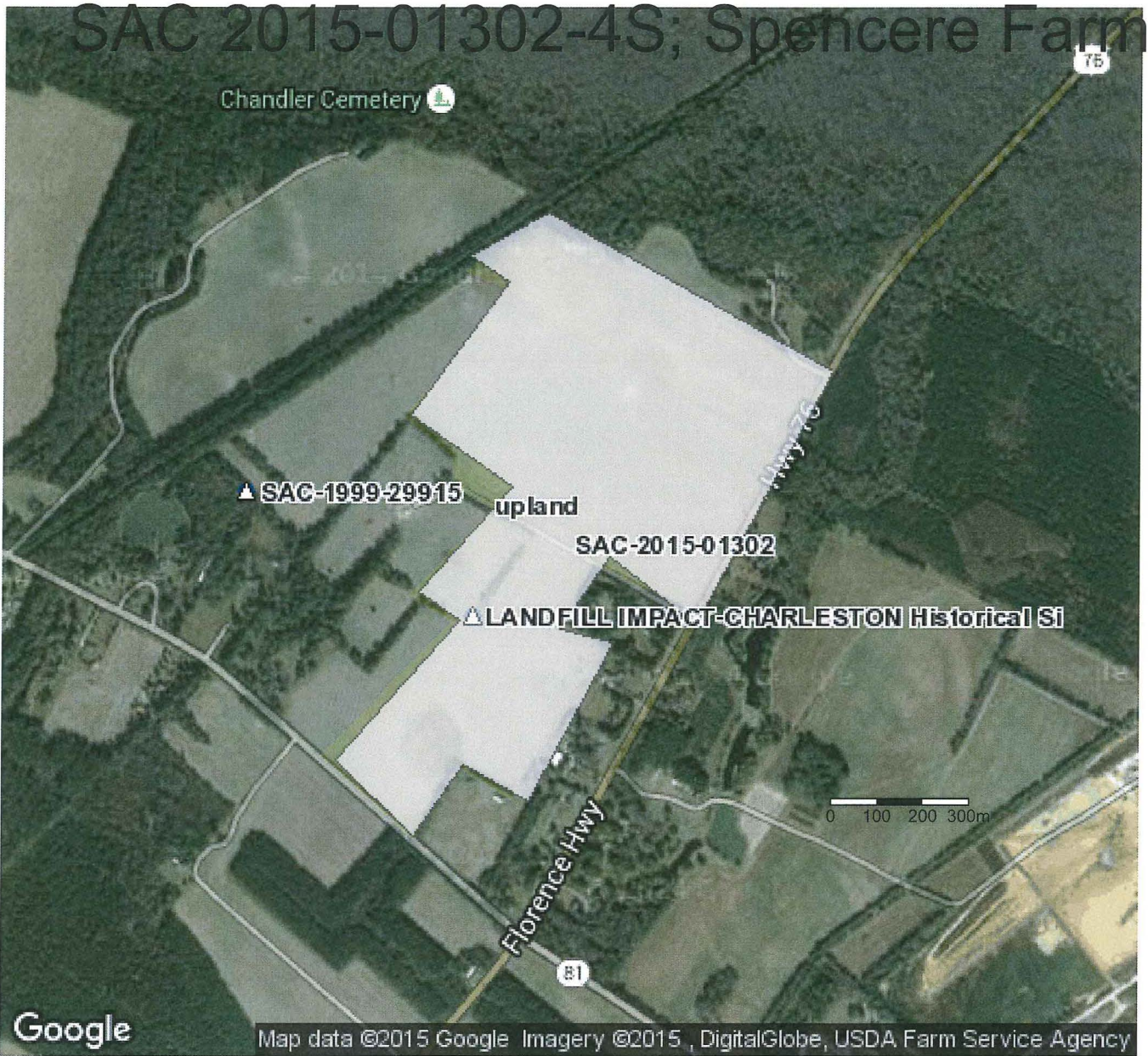
