**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Upland soils displayed a high (<30%) perenctage of uncoated sand grains in the upper 6-10". Additionally, soil saturation was observed at approximately 14-16" under below normal rainfall conditions. (North Myrtle Beach was -2.1" below normal for the preceding week).**

**Vegetation throughout the upland portion was dominated by Bracken Fern (*Pteridium aquilinum*) in the herb layer and with a sparse presence of Black Cherry (*Prunus sertotina*). Tree stratum was dominated by Pond Pine (*Pinus serotina*). Vegetation in the upland portion varied by the presence of these species as opposed to the remaining wetland portions of the site. .**
