- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One non-jurisdictional isolated wetland is located on the south side of the subject property. The Isolated Non-Jurisdictional Wetland is a 1.8 acre wetland entirely surrounded by uplands. A previous jurisdictional determination south of this site indicated this wetland was isolated. The area south of the site has been cleared and filled under SAC-2011-00423. The wetland on the subject property would also be considered isolated prior to the permitted fill. There was no apparent surface or shallow subsurface hydrologic connection, no apparent connection to interstate or foreign commerce and no apparent evidence of ecological interconnectivity between this isolated wetland and waters of the U.S. Therefore this wetland was determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.**

A non-jurisdictional upland dug borrow pit is located at the north end of the site. This upland dug feature is surrounded by uplands and is bordered by a 3-4 ft berm on the east side, a road on the north and west side, and housing on the south side. The borrow pit was full of water due to high ground water table and was void of vegetation within the borrow pit. As stated in the Preamble to the November 13, 1986 Regulations found on page 41217, (Federal Register Vol 10151 No. 219) “waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States.” are generally not considered waters of the United States. There was no apparent surface or shallow subsurface hydrologic connection, no apparent connection to interstate or foreign commerce and no apparent evidence of ecological interconnectivity between this isolated wetland and waters of the U.S.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
