**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 1.41 acre tract that is determined to consist entirely of uplands. Available desktop resources depict the project area as being comprised entirely of uplands. The USGS topographic survey information within the Bucksville Quad depicts the project area as cleared uplands that do not contain any blue line features or other symbols that would typically represent a WOUS. NWIs depict the project area as being comprised entirely of Upland Evergreen Forest. An aerial photograph taken in 2005 depicts the entire project area as cleared uplands that do not contain any features that would indicate the presence of a water of the United States. Additionally, the site was determined to consist of uplands in Approved JD SAC 53-92-0047 issued on January 21, 1992 and Approved JD SAC 84-97-1590 issued on October 9, 1997.
