in Preliminary JD SAC 2015-01656 issued on December 16, 2015. Based on site photos and data sheets submitted by the agent this feature was excavated out of non-hydric soils. The site also includes 0.11 acres of an isolated non-jurisdictional wetland. Based on data sheets and site photos submitted by the agent, the wetland is a depressionnal feature surrounded on all sides by uplands that do not meet the hydrology criteria and/or hydric soils criteria set forth in the 87 manual and therefore disrupt any possible hydrologic connection between the isolated wetland and any other WOUS. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site contains one upland excavated non-jurisdictional ditch that does not provide a hydrologic connection between the isolated wetland on site and any downstream WOUS. The site also includes 0.14 acres of a jurisdictional wetland first identified in Preliminary JD SAC 2015-01656, issued on December 16, 2015. Based on data sheets and site photos submitted by the agent, soils within the wetland were saturated at 10 inches and met a S7 Hydric Soils indicator (Dark Surface). Secondary indicators of hydrology were also present and include moss trim lines, Fac-Neutral test, and Sphagnum moss.

The site also contains 0.11 acres of Non-Jurisdictional Freshwater Wetlands that were determined to lack a discernable or traceable outfall to a downstream TNW and that are addressed on Basis Form 1 of 2.
