**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Letter dated November 19, 2008). Notes taken in the field during the site visit on September 23, 2008 regarding flow characteristics state that the tributary had a well defined OHWM, however, the tributary was partially impaired due to silviculture activities. Stream classification of the RPW was determined just offsite where the tributary was not affected by the silviculture activities and was in a more natural state. The tributary was observed having a well defined channel clear of vegetation and debris, firm sandy bottom, and an even distribution of substrates along the stream channel. It was determined that the tributary flows continuous at least 90% of the year under normal conditions. Pictures submitted by the consultant on October 10, 2017 indicate that the tributary has not changed and still exhibits perennial flow.
