jurisdictional since they do not exhibit an OHWM, bed and bank, or flow characteristics, nor do they transport water from one water of the U.S. to another. The only hydrological input to these features is upland stormwater runoff from the adjacent upland areas. For these reasons, the ditches were determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The wetlands located onsite directly abut this onsite tributary. The tributary then flows directly into the agricultural pond, where it then exits at an overflow flashboard riser and into a culvert. The tributary then continues its flow regime from the culvert, north to the Wadmalaw River. The tributary feature had bed and bank, ordinary high water mark (OHWM), and was carrying surface water flow from Wetland A during the date of the site visit on November 9, 2016. Due to the capacity of flow observed, as well as tributary dimensions, the flow regime of the tributary would be classified as perennial. In addition, the reference site contains 0.81 acres of a jurisdictional RPW Pond. The RPW Pond was previously excavated in waters of the United States (Tributary A), has an OHWM, and contains a piped outfall that discharges offsite into a continuation of Tributary A, which then flows**

**into a TNW. Therefore, the RPW Pond is a Water of the United States. Lastly, the pond feature appears to exhibit year-round inundation, and would be considered to have relatively permanent water on a perennial basis.**

The wetland area is determined to be waters of the U.S. and therefore subject to CWA 404 jurisdiction, as it is directly abutting an onsite perennial tributary that directly flows into a TNW (Wadmalaw River). An onsite tributary, identified as pRPW Tributary A, directly connects into the Wadmalaw River north of the subject property. The wetlands located onsite directly abut this onsite tributary. The tributary then flows directly into the agricultural pond, where it then exits at an overflow flashboard riser and into a culvert. The tributary then continues its flow regime from the culvert, north to the Wadmalaw River. The tributary feature had bed and bank, ordinary high water mark (OHWM), and was carrying surface water flow from Wetland A during the date of the site visit on November 9, 2016. Due to the capacity of flow observed, as well as tributary dimensions, the flow regime of the tributary would be classified as perennial. In addition, the reference site contains 0.81 acres of a jurisdictional RPW Pond. The RPW Pond was previously excavated in waters of the United States (Tributary A), has an OHWM, and contains a piped outfall that discharges offsite into a continuation of Tributary A, which then flows into a TNW. Therefore, the RPW Pond is a Water of the United States and subject to regulation under Section 404 of the CWA.
