- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are two (2) stormwater ponds and ten (10) linear features located within the project review area that were determined to be non-jurisdictional. The 2 stormwater ponds are vegetated and meet the three parameters of a wetland; however, they are stormwater ponds that were permitted by SCDHEC, Permit No. SCR001324 which became effective on October 1, 2016. In addition, the project review area was part of a previous jurisdictional determination, SAC-2008-00109, for the Charleston International Airport that showed the area of the stormwater ponds as being uplands. The jurisdictional determination was issued on October 9, 2008. For these reasons, the two stormwater ponds were determined to be non-jurisdictional and not regulated by Section 404 of the CWA.**

In addition to the ponds, 10 linear features are also present within the project review area. The 10 linear features are roadside drainage ditches and swales. They were constructed from uplands for the purpose of draining stormwater from adjacent uplands. Some of the ditches flow directly into the two stormwater ponds while some of the other ditches flow offsite to a large canal and stormwater pond and eventually the Ashley River. The linear features did not have defined beds and banks and did not display ordinary high water marks. For these reasons, the linear features were determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
