This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

within the tributary can be observed year round from public access points from Main Street and Mill Pond Road in Conway, SC. The feature is depicted as a solid purple line cut through wetlands on the USGS topo map. Horry County Drainage studies depict the feature as a main drainage canal. A clear channel with bed and banks can be seen in aerial photographs and the feature is depicted as water on NWIs and Horry County Soil surveys. This feature flows into Kingston lake when discharges into the Waccamaw River, a TNW.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 1.47 acres site that contains 0.49 acres of jurisdictional freshwater wetlands. Uplands on site has soils with high chroma and value and did not contain any indicators of hydrology. Wetlands on site are separated from uplands by an obvious topographic break. Soils within wetlands were low chroma and value and were saturated to the surface. Water stained leaves and drainage patterns were also observed within the wetlands. One upland excavated non-jurisdictional ditch is located on site. This feature did not have any observable indicators of flow during the site visit conducted on October 11, 2017 .**
