- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **On site is a 0.14 acre pond and 6,871 linear feet of ditching, consisting of seven ditch segments (91 ln. ft., 99 ln. ft., 202 ln. ft., 1,178 ln. ft., 1,263 ln. ft., 1,918 ln. ft., and 2,120 ln. ft.). All of these features are manmade storm-water conveyance and capture systems excavated out of uplands that lack the necessary hydrology to support wetlands. All features are excavated out of NWI labeled uplands (U42P), with the exception of the farthest southern ditch segment, which is within an area labeled as a palustrine wetland (PFO1/4B), however was assessed by the consultant and found not to meet wetland criteria. All of the linear features on site do not feature adjacent wetlands, convey/contain flow due to rainstorms, and do not meet the criteria of a Waters of the United States, per CFR 328.3 paragraphs (a)(1)-(4) and the Rapanos-Carabell Guidance dated December 3, 2008. Therefore, these features are non-jurisdictional, per the Corps authority.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

On site is a 0.14 acre pond and 6,871 linear feet of ditching, consisting of seven ditch segments (91 ln. ft., 99 ln. ft., 202 ln. ft., 1,178 ln. ft., 1,263 ln. ft., 1,918 ln. ft., and 2,120 ln. ft.). All of these features are manmade storm-water conveyance and capture systems excavated out of uplands that lack the necessary hydrology to support wetlands. All features are excavated out of NWI labeled uplands (U42P), with the exception of the farthest southern ditch segment, which is within an area labeled as a palustrine wetland (PFO1/4B), however was assessed by the consultant and found not to meet wetland criteria. All of the linear features on site do not feature adjacent wetlands, convey/contain flow due to rainstorms, and do not meet the criteria of a Waters of the United States, per CFR 328.3 paragraphs (a)(1)-(4) and the Rapanos-Carabell Guidance dated December 3, 2008. Therefore, these features are non-jurisdictional, per the Corps authority.

LiDAR depicts an upland site bisected by a local use road, as well as the previously mentioned pond and seven ditches. No other significant ditching or elevation slopes are within the project site.

The Florence County soil survey, Pg. 5, depicts a matrix of seven soils on-site, including: Coxville fine sandy loam, Duplin fine sandy loam (Dp), Varina loamy fine sand (0-2% slopes) (VaV), Norfolk loamy sand (0-2% slopes) (NoA), Lynchburg sandy loam (0-2% slopes) (Ly) Faceville loamy sand (0-2% slopes), and Goldsboro loamy sand (Go). Of the on-site soils all but Duplin fine sandy loam (Dp) is listed as hydric on the 2016 South Carolina hydric soils list for Florence County.

Florence West quadrangle USGS topographic map depicts a mostly non-forested site with four solid blue line features that correlate to the approximate position of the on-site excavated drainage ditches.
