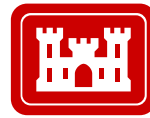

The project boundary does not intersect the MHW of the AMWW.

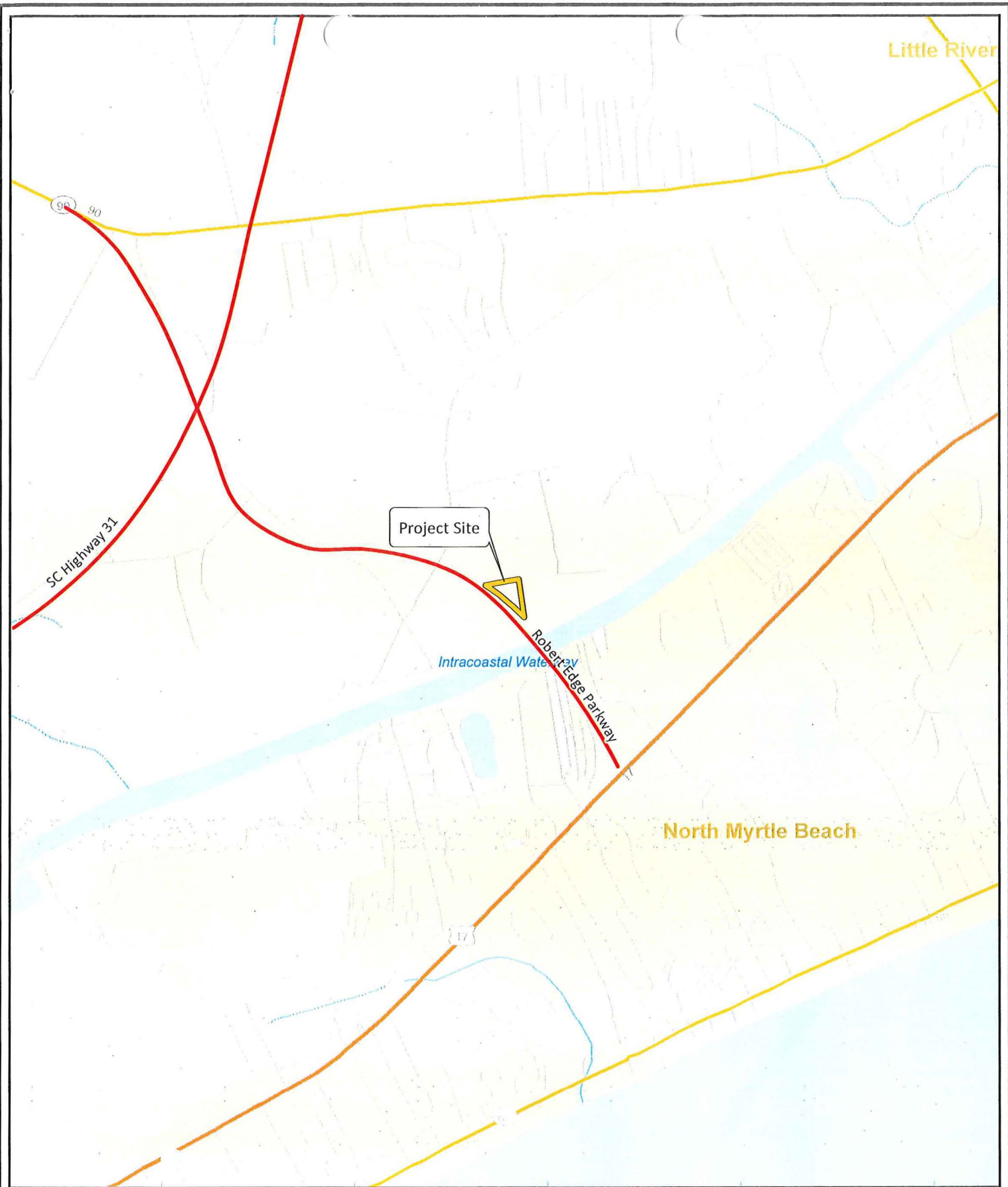
