excavated out of the agricultural field the site is located within; this ditching is common in agricultural fields of the region and serves only to convey storm-water away from the agricultural field to the roadside ditch. Both ditch features are manmade storm-water conveyance systems excavated out of uplands, convey only occasional flow due to seasonal rain, do not feature adjacent wetlands, and do not meet the criteria of a tributary of Waters of the United States, per CFR 328.3 paragraphs (a)(1)-(4) and the Rapanos-Carabell Guidance dated December 3, 2008. Therefore, these features are non-jurisdictional, per the Corps authority.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This 0.034 acre rectangular shaped site, located within the farming community of Little Rock, in Dillon County, South Carolina, consists in its entirety of uplands and is non-jurisdictional, per the Corps jurisdictional authority. The following statements substantiate the findings of a review of all applicable information including aerial imagery, National Wetland Inventory maps, USGS Topography maps, LiDAR, Soil Survey maps, and a September 10, 2018 site visit conducted by the Corps.

Aerial imagery depicts the site as the southeast corner of an agricultural field, the eastern boundary of the site is bounded by Sinclair road, the southern boundary of the site is bounded by an off-site excavated drainage ditch, and the west and northern boundaries are bounded by the agriculture field the site is within.

Within the site is 25 feet of a ~3,670 foot roadside ditch running adjacent and west of Sinclair Road. Additionally, located off-site but adjacent to the projects south-southeast border, is 30 feet of an ~660 foot ditch excavated out of the agricultural field the site is located within; this ditching is common in agricultural fields of the region and serves only to convey storm-water away from the agricultural field to the roadside ditch. Both ditch features are manmade storm-water conveyance systems excavated out of uplands, convey only occasional flow due to seasonal rain, do not feature adjacent wetlands, and do not meet the criteria of a tributary of Waters of the United States, per CFR 328.3 paragraphs (a)(1)-(4) and the Rapanos-Carabell Guidance dated December 3, 2008. Therefore, these features are non-jurisdictional, per the Corps authority.

LiDAR depicts a flat site bounded by Sinclair Road to the east-southeast, as well as two ditches: one on-site and adjacent to Sinclair Road, the other off-site to the south and cutting northeast-southwest through the agricultural field the site is within.

Dillon West USGS Quad depicts an upland non-forested site bounded by solid blue line features, (roadside and agricultural ditches) that historically led through a series of excavated ditches and an intermittent aquatic feature under Sinclair Road to a drainage basin located 0.35 miles to the northeast. The majority of the ditches adjacent to either side of Sinclair Road are still present, however Aerial imagery, Google Street View, and LiDAR no longer support that the ditching on-site / adjacent to the site, west of Sinclair Road, no longer connects to a conveyance under Sinclair road to the storm-water impoundment.

This site was assessed on a single basis form per the provided site maps.
