- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: On-site are two ditches excavated out of uplands for storm-water conveyance from low-lying areas to a roadside ditch adjacent of Highway 17 to the east, and off-site, of the project. For clarification these ditches will be referred to as Ditch A and Ditch B; Ditch A is located directly on the southern project border with an approximate length of 475 linear feet, and Ditch B is located in the northwestern corner of the project with an approximate length of 25 linear feet. Neither ditch is directly depicted on USGS topographic maps nor do they feature adjacent wetlands depicted on the National Wetland Inventory. However, Ditch A is located adjacent (approx. 260-330 ft. north) to a dashed blue line feature depicted on the USGS topographic map that does not exist anymore; this feature was an unnamed tributary of Collins Creek but was significantly altered due to commercial development in the area multiple decades prior. Both ditches feature less than seasonal flow, only serve to convey storm-water during heavy precipitation, do not have adjacent wetlands, and are excavated features out of uplands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Other information (please specify): ArcGIS LiDAR Digital Elevation Model (DEM) utilizing both colorized and monochromatic “Hillshade” curves were used to assess the site for elevation contrasts typical of aquatic resources. The site is depicted as relatively flat with a small elevation gain in the central-western portion of the site. Additionally, a ditch feature can clearly be seen bounding the southern boundary of the site and continuing off-site in either direction; this ditch feature connects to an off-site upland pond (an Indigo Creek Golf Course water hazard) to the west and the Highway 17 roadside drainage ditch system to the east, both of which are non-jurisdictional per the USACE’ authority.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Sea Coast Property Services project consists of a 2.4 acre forested and non-forested site within an area of residential and commercial development. A site visit was not performed, however, a review of provided maps, data sheets, and site photos, as well as aerial imagery, NWIs, LiDAR, soil survey maps, and USGS Topographic maps gathered by the Corps was executed. This analysis has led to the conclusion that the site, as depicted on the provided maps, is in its entirety upland with no aquatic resources under the Corps jurisdiction. The following statements substantiate the findings of the Corps:

Aerial imagery, dating from 1999 to 2016, depicts a mostly forested site with no apparent tributaries, wetlands, nor any other WOTUS. The only feature of note is a northwest-southeast linear pattern of vegetation that can be seen on the projects southern border, which correlates to emergent vegetation on either side of an upland excavated ditch (discussed below).

On-site are two ditches excavated out of uplands for storm-water conveyance from low-lying areas to a roadside ditch adjacent of Highway 17 to the east, and off-site, of the project. For clarification these ditches will be referred to as Ditch A and Ditch B; Ditch A is located directly on the southern project border with an approximate length of 475 linear feet, and Ditch B is located in the northwestern corner of the project with an approximate length of 25 linear feet. Neither ditch is directly depicted on USGS topographic maps nor do they feature adjacent wetlands depicted on the National Wetland Inventory. However, Ditch A is located adjacent (approx. 260-330 ft. north) to a dashed blue line feature depicted on the USGS topographic map that does not exist anymore; this feature was an unnamed tributary of Collins Creek but was significantly altered due to commercial development in the area multiple decades prior. Both ditches feature less than seasonal flow, only serve to convey storm-water during heavy precipitation, do not have adjacent wetlands, and are excavated features out of uplands.

ArcGIS LiDAR Digital Elevation Model (DEM) utilizing both colorized and monochromatic “Hillshade” curves were used to assess the site for elevation contrasts typical of aquatic resources. The site is depicted as relatively flat with a small elevation gain in the central-western portion of the site. Additionally, a ditch feature can clearly be seen bounding the southern boundary of the site and continuing off-site in either direction; this ditch feature connects to an off-site upland pond (an Indigo Creek Golf Course water hazard) to the west and the Highway 17 roadside drainage ditch system to the east, both of which are non-jurisdictional per the USACE’ authority.

Horry County soil survey depicts two soils on-site: Ogeechee loamy fine sand and Yonges fine sand, both of which are hydric soils on the 2016 South Carolina Hydric Soils List for Horry County. The data sheets provided by the consultant did note hydric soil, however the site lacked wetland hydrology and hydrophytic vegetation, as assessed by the consultant.

Brookgreen USGS Quad depicts a forested site with no aquatic (blue line) features within the project area.

The National Wetland Inventory lists the site in its entirety as Upland - Commercial Use (U21).

This site was assessed on a single basis form per the provided maps and location information.
