**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other information (please specify): **LiDAR Digital Elevation Model with a “Hillshade” monochromatic color curve was used to analyze the site for any potential elevation gradients that are indicative of aquatic resources, which none were found within the project site. However, two ditches excavated out of uplands bounding the project on the southern (~800 ln. ft.) and western borders (~1607 ln. ft.) could be seen on LiDAR. These ditches are not shown on USGS topographic maps and do not directly or indirectly lead to aquatic resources. Additionally, site pictures of these ditches do not depict flow characteristics of jurisdictional tributaries.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The Luz Solar project site consists in its entirety of a 30 acre agricultural use field. Aerial imagery and topographic maps depicts this site as an upland farm (crop) field that is bounded on the south by West Billy Farrow Highway, to the West by an upland excavated ditch, to the east by an unimproved farm road, and to the north by Atlantic Coast Railway.**

**The nearest jurisdictional aquatic resource, the Cogdell Branch, a tributary of Black Creek, is ~430 ft. northeast from the far northeast corner of the project site and curves to the west, away from the project site for ~900 ft. where it then continues south through a series of ditches and culverts, away from the project site.**

**LiDAR Digital Elevation Model with a “Hillshade” monochromatic color curve was used to analyze the site for any potential elevation gradients that are indicative of aquatic resources, which none were found within the project site. However, two ditches excavated out of uplands bounding the project on the southern (~800 ln. ft.) and western borders (~1607 ln. ft.) could be seen on LiDAR. These ditches are not shown on USGS topographic maps and do not directly or indirectly lead to aquatic resources. Additionally, site pictures of these ditches do not depict flow characteristics of jurisdictional tributaries.**

**Hartsville Quad USGS topographic map depicts an upland non-forested site with no aquatic resources on site.**

**Darlington County soil survey depicts a matrix of four soil types, including: Norfolk loamy sand with 0-6% slopes (NoA/NcB), Rains sandy loam (RaA), Blanton sand with 0-6% slopes, and Goldsboro sandy loam with 0-2% slopes (GoA). All of the soils on site are listed on the 2016 South Carolina Hydric Soil List, however hydric soil was not found on-site during a May 25, 2018 site visit by Pilot Environmental, Inc.**
