The proposed work consists of the construction of eleven private recreational docks for the future eleven property owners. In detail there are minor changes to the boat lifts proposed at the dock facilities from the advertised public notice dated July 10, 2015, as follows:

- 1: SAC-2015-00759-1IW-** a 435' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 2: SAC-2015-00760-1IW** a 344' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 3: SAC-2015-00761-1IW** a 215' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 4: SAC-2015-00762-1IW** a 215' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 5: SAC-2015-00763-1IW** a 148' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 6: SAC-2015-00764-1IW** a 500' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 7: SAC-2015-00765-1IW** a 180' x 4' walkway leading to a 10' x 12' fixed pierhead and a 12' x 12' four pile boat lift, not a 6' x 8' floating boat lift.
- 8: SAC-2015-00766-1IW** a 180' x 4' walkway leading to a 10' x 12' fixed pierhead and a 12' x 12' four pile boat lift, not a 6' x 8' floating boat lift.
- 9: SAC-2015-00767-1IW** a 100' x 4' walkway leading to a 10' x 12' fixed pierhead and a 12' x 12' four pile boat lift, not a 6' x 8' floating boat lift.
- 10: SAC-2015-00768-1IW** a 450' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.
- 11: SAC-2015-00769-1IW-** a 660' x 4' walkway leading to a 10' x 12' fixed pierhead and a 6' x 8' single pile boat lift, not a floating boat lift.

**There are no other changes from the work proposed in the original public notice dated 10 July 2015.**

Department of Health and Environmental Control. The District Engineer will not process this application to a conclusion until such certifications are received. The applicant is hereby advised that supplemental information may be required by the State to facilitate the review.
