## NOTICE OF AVAILABILITY DRAFT FEASIBILITY REPORT / ENVIRONMENTAL ASSESSMENT AND PROPOSED DRAFT FINDING OF NO SIGNIFICANT IMPACT FOR THE CHARLESTON PENINSULA COASTAL FLOOD RISK MANAGEMENT STUDY, CHARLESTON, SOUTH CAROLINA

## NATIONAL ENVIRONMENTAL POLICY ACT / NATIONAL HISTORIC PRESERVATION ACT

The U.S. Army Corps of Engineers (USCAE), Charleston District and City of Charleston are performing a feasibility study to evaluate storm surge risk reduction measures for the Charleston Peninsula. The goal is to reduce risks to health, safety, and economic damages from coastal storm surge inundation on the peninsula. An integrated Draft Feasibility Report/Environmental Assessment has been prepared to present the results of the study to date, and to analyze impacts of the proposed measures on the environment.

The Draft Feasibility Report/Environmental Assessment was prepared in accordance with the National Environmental Policy Act (NEPA). It evaluates potential impacts of the alternative actions on the environment, including the no-action alternative. The Report also integrates the National Historic Preservation Act (NHPA) Section 106 process to provide the public with information about this undertaking and its effects, and includes a draft Programmatic Agreement to address historic and cultural resources. Based on the Environmental Assessment, the U.S. Army Corps of Engineers has proposed a Draft Finding of No Significant Impact (FONSI).

USACE and the City recognize that, while a great deal has already been accomplished in the Study process, much additional work will be completed before a Final Report is produced. Accordingly, USACE and City of Charleston invite the public to review and comment on the Draft Feasibility Report/Environmental Assessment for purposes of NEPA and the NHPA and on the proposed Draft FONSI for 60 days, from April 20 to June 19, 2020.
