- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Potential wetlands on site were examined during a site visit on 4/15/15. At the time of the site visit no hydrology or indicators of hydrology were observed. Several soil samples were taken at low lying points within the project area. Soils were determined to be non-hydric due high chroma. Due to the lack of hydrology or indicators of hydrology, and the lack of hydric soils, the three parameters which define a wetland as outlined in the 1987 USACE Wetland Delineation manual were not met. Therefore, the project area was determined to be void of any freshwater wetlands.**

One upland excavated non-jurisdictional ditch is located on site, along the northern property boundary. This ditch begins off site and terminates within the project area. This ditch was determined to have been excavated entirely out of uplands and to drain only uplands and therefore is not a jurisdictional feature.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 4.51 acre tract that was determined to consist entirely of uplands. During a site visit conducted on 4/15/15 the site was determined to lack any evidence and/or indicators of hydrology. Soils on site were mapped hydric (Coxville sandy loam) by the Sumter County soil survey however; soils had high Chroma inconsistent with Coxville sandy loam. An upland excavated non-jurisdictional ditch was located on site along the northern project boundary. This ditch originates off-site and terminates within the boundaries of the project area. This ditch was determined to drain into the project area based on evidence of leaf litter and debris being washed towards the site. This site is determined to be void of any aquatic resources.
