**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The reason for this is that the referenced tract contains 8.25 acres protected by Restrictive Covenants under Department of the Army permit SAC# 2003-04737-3NI. These 8.25 acres depicted as "PROTECTED AREA UNDER SAC-2003-04737-3NI REF PLAT #9" on the above referenced plat were not reviewed and therefore not included in this determination. Of the remaining 20.86 acres, 0.21 acres have been determined to be waters of the United States (TNW), the Atlantic Ocean.**
