that it is surrounded by uplands and lacks signs of relatively permanent flow. Therefore, it has been determined the ditch is non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act. It is depicted in the administrative record on the plat and noted as the center line of a 50' drainage easement.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

There are no “navigable waters of the U.S.” within the review area nor are there “waters of the U.S.” within the review area. Furthermore, this JD form documents the jurisdictional status of a drainage ditch that transects the proposed project site. It was determined the drainage ditch was excavated wholly out of uplands, drains uplands and drains an offsite stormwater retention area. It was confirmed during a site visit that it is surrounded by uplands and lacks signs of relatively permanent flow. Therefore, it has been determined the ditch is non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act.
