The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). 



C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The area in review contained no Waters of the U.S. or wetlands. The project area is comprised of the hydric soils Yemasse soils and Brookman soils. Horry county NWI data depicts the site as U21 (Cropland/Pasture) and no potential jurisdictional features were located onsite. The project site is approximately 2500 linear feet from the nearest jurisdictional feature as depicted on USGS topographic maps. USGS topographic information and aerial photography depict the site as an upland forested area adjacent to commercial and residential development. During a field visit conducted under SAC-2010-01409 on June 21, 2011 several shallow drainage features were observed. They were determined to convey surface water during or after storm events. These features were very shallow, and void of surface or subsurface flow in the hyporhic zone. No OHWM, bed, banks, or other jurisdictional features were observed during the site visit.
