

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review (project area 1.55 acres / TMS# 129-00-06-020) contains no wetlands or other Waters of the U.S. (WOUS) based on a review of aerial imagery, LIDAR, NWI maps, and Horry County Soil

Survey. This site is comprised of Bladen soils (hydric), Horry County NWI data depict the site entirely as U42P (uplands). USGS Topographic Maps depict the site as an forested upland with no wetland symbology. Additionally, 2015 Horry County LIDAR data depict the site a nearly uniform and higher in elevation compared to that of areas coinciding with wetland symbology on USGS Topographic maps. All sources point to the site being an upland area with planted or natural pine regeneration.
