linear conveyance 1 runs along the southern boundary and is a stormwater drainage ditch. The linear conveyance is vegetated, lacks a defined bed and bank, and does not appear to display evidence of relatively permanent flow. It appears to drain only uplands and carries stormwater flow from nearby roads. For these reasons, linear conveyance 1 was determined to be non-jurisdictional and not regulated by Section 404 of the CWA. Non-jurisdictional linear conveyance 2 is located on the northern side of the project review area. It does not have a defined bed and bank, no OHW mark, and displays no evidence of relatively permanent flow. For these reasons, non-jurisdictional linear feature 2 was determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
