B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review (project area 79.1 acres / Upland area 1 / 17.3, Upland area / 38.8, Upland area 3 / 8.2, Upland area 4 / 9.2, Upland area 5 / 5.6) contains no wetlands or other Waters of the U.S. (WOUS) based on a site audict and review of aerial imagery, LIDAR, NWI maps, and Horry County Soil Survey. During the site visit, the soils displayed a mixtured of high chroma soils and lack of hydrology with marginally facultavtive vegetation. No hydric soils were observed throughout the 4 upland areas. According to Georgetown County Soil Survey data, this site is comprised of Leon (hydric), Yauhannah, Centenary, Echaw, and Udorthents (non-hdyric) soils series. Georgetown County NWI data depict the site Primarily as U42P (uplands) with small inclusions of PSS1/4Bd, PEM1C, PFO1/4B, and PFO1C palustrine wetland symbology, although wetlands were not observed in the field. USGS Topographic Maps depict the site as a mixture of forested upland and wetland symbology. Field observation and a review of available resources confirm the site being an upland area.

Located onsite are several upland excavated non-jurisdictional ditches constructed alongside the unimproved roads that traverse the upland areas. During the site vist, no jurisdicitonal features or connections to other WOUS where observed in the field. These features convey surface water from storm events only.
