## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was conducted on 3-23-17. Based on a review of the aerial photographs, topographic maps, soil survey information, NWI maps, and data sheets and pictures submitted by the consultant, it was determined that the site consist entirely of uplands. The topographic map does not depict any wetlands or waters on site. The soil survey information gathered shows that the site is mapped as Noboco (loamy sand) soil which only has a 2% hydric component. The NWI for the site is mapped as (U11) Upland. With the researched information it was determined that the subject site consists entirely of uplands, and, as such, Department of the Army authorization will not be required for mechanized land clearing, excavation, or the placement of dredged or fill material on this site.
