

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site within the review area is entirely comprised of uplands with a nonjurisdictional linear feature cutting across the review area. The linear feature was determined to be an upland excavated ditch that drains only uplands. It was dug out of uplands and lacked an OHWM or any other indicators that would establish it as a WOUS. USGS topographic survey information depicts a forested area and is void of any blue line features or wetland symbols. Soil survey information shows the project area is comprised of the non-hydric soils Udorthents and Udipsamments and the hydric soil Yonges. NWI maps depict the project area as an upland urban area. Based on a combination of the above listed resources the project area was determined to be void of aquatic resources.
