C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was completed on April 7, 2017. All available resources were used to make the determination for the site in question. The aerial photography, topographic maps, soil data information, NWI maps, Wetland Determination Data Forms, and site photographs submitted by the consultant were all reviewed and used to make the Jurisdictional Determination. The site does contain an upland excavated, non-jurisdictional ditch which is located on the northeast portion of the site. The site also includes an upland excavated, non-jurisdictional pond which is approximately 0.7 acres and is located in the southwest portion of the site. These two features are non-jurisdictional and not regulated by the USACE. The topographic map does not depict any jurisdictional features that the USACE regulates, the National Wetlands inventory maps the site as being U13 Uplands, and the soil type for the site is Varina sandy loam with 0 to 2 percent slopes and has 0% hydric rating and is graded as an Upland soil type. So, with all of the information gathered it was determined that the site in question consists entirely of Uplands. .
