of this wetland was observed in the field. The wetland is completely surrounded by non-hydric soils and no surface or shallow subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, and topographic maps. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical or biological connections, the wetland was determined to be isolated non-jurisdictional with no connection to any other waters of the U.S. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland identified within the project area was determined to be isolated (non-jurisdictional). The entire perimeter of the wetland was observed on the site visit of March 30, 2018. The wetland is completely surrounded by soils that do not meet any hydric soil indicators. The project area is surrounded on all four sides by established development (i.e. existing public roads, established local businesses, etc.). the site visit revealed no surface or shallow subsurface connections to any water of the United States. All water is contained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernible outfalls, topography grades, and lack of evidence of chemical or biological connections, the wetland was determined to be isolated non-jurisdictional and not connected to any other water of the U.S. In addition, previous determinations dated 10/6/03 & 02/12/2012 documented in SAC 87-2003-1020 and 2003-41134-3JH determined the wetland area to be isolated nonjurisdictional.
