- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is one roadside swale/ditch located on the property along John Ballam Road. This feature is approximately one half foot deep, two feet wide and 1,040 feet long. The feature was filled with leaf litter and had no water or indication of flow on the day of the site visit. This feature was determined to be non-jurisdictional as it was excavated wholly from uplands, and did not contain an OHWM or flow. This feature appeared to have been constructed to convey water only during significant rain events.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

OHW. The substrate consists of sand and silt. A clear defined stream channel was observed in the field. This tributary transects the property boundary along the eastern property line is part of a larger tributary that provides drainage and flow between approximately 120 acres of upstream wetlands and waters of Gray Bay. Topographic maps indicate the tributary is a blue line feature. As a result, sufficient water is available to support flow-dependent aquatic life, including fish. The tributary consists of a sinuous channel that exhibits physical and hydrological characteristics commonly associated with normal flow including discernible bank and streambed, vegetation, leaf litter, and debris that may provide habitat. Larger wildlife such as mammals and wading birds may also utilize the tributary as a food and water source; as well as a corridor for movement of aquatic organisms.

B. ADDITIONAL COMMENTS TO SUPPORT JD: It is the determination of this office that the 7.77 acre tract in question contains 350 linear feet (or 0.050 acre) of Waters of the U. S. (pRPW) subject to regulation under Section 404 of the Clean Water Act. The tributary (pRPW) appears to flow most of the year and is a solid blue line feature on topographic maps. The pRPW located within the project boundary is part of a larger tributary that provides flows between upstream wetlands and Gray Bay, a TNW. Therefore, the pRPW located within the project boundary is jurisdictional and subject to Section 404 of the Clean Water Act.
