# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland hydrology was present within the boundaries of wetlands 1-4. Horry county NWI data depict the site as uplands, however wetland areas were observed in the field. The isolated wetlands are approximately 600 linear feet from the nearest WOUS (wetlands adjacent to Socastee Swamp) feature as depicted on USGS topographic maps and Google earth true color aerial imagery.

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

# **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

Area in review is comprised of 35.52 acres and contained a single jurisdictional wetland (wetland 5/0.33 acres). Waters of the U.S. (WOUS). Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Wetlands were saturated at the time of the site visit in contrast to the upland onsite that lacked the appropriate hydrology and contained greater than 30% of uncoated sand grain in the upper 12 inches. Wetland 5 continues offsite and is bisected by the OHWM of a perennial RPW known as Socastee Swamp which is a first order tributary that eventually becomes to tidal influence prior to discharging into the Atlantic Intracoastal Waterway (AIWW).
