- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains two isolated wetlands (Wetland B = 0.08 acre and Wetland C = 0.52 acre). The footprint of the isolated wetlands were once used for wastewater ponds that were constructed in the uplands regulated under Section 402 of the Clean Water Act under the National Pollutant Discharge Elimination System (NPDES). The wastewater ponds have since been filled and closed out by the state regulatory agency, SCDHEC Wastewater Program. The fill within the wastewater ponds has settled into depressional pockets in the landscape and the areas have developed into wetlands as detailed in the wetland delineation manual and regional supplement. In addition to utilizing remote resource tools (to include USGS Topographic map, soil surveys, LIDAR, infrared aerial photography, and historic aerial photographs found on Google Earth Pro), a field inspection was completed on September 26, 2018. The wetlands are surrounded by uplands; they have no apparent physical, chemical, or biological connection to waters of the U.S.; and they have no apparent surface or shallow subsurface hydrologic connections to waters of the U.S. The wetlands also have no connection to interstate or foreign commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
