# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site visit was conducted on February 22, 2019, for the purpose of verifying a wetland delineation submitted by the Brigman Company on behalf of Ms. Glenda Williams of John Leigh Properties. Wetlands on site were saturated to the surface. Soil met a thick dark surface indicator and water stained leaves were present in the obvious depression. Obligate and FAC wet species dominated the herbaceous and shrub layers within the wetland. A pond located on site was determined to have been excavated out of wetlands. Saturated hydric soils continued to the edge of the pond and the water table was level with the water in the pond (approx... 8 inches from the surface). Soils in uplands were higher chroma and value, were not saturated and contained greater than 30% uncoated sand grains. Based on desk top review that wetland continues offsite to the south and abuts a man altered perennial RPW north of the terminus of Manning Street. This feature flows into Juniper Swamp, which flows into Grisset Swamp, then Seven Creek, and then the Waccamaw River a TNW.
