C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses two lots comprising of 1.06 acres. Of those acres 0.67 acres were determined to be jurisdictional wetlands directly abutting an offsite pRPW. The RPW was determined to have perennial flow by review of Ariel photos, topographic maps, and site visit. Wetlands continue off-site to the north until they intersect the pRPW. The RPW consist of ponds that were connected by culverts to a channel that has a culvert connection under Kings Road and discharges into a blue line stream on topographic maps which is contiguous to Waverly Creek. .
