Four Hole Swamp has numerous navigable tributaries that are navigable in fact. Due to the navigability of the braided tributary system, Four Hole Swamp is considered a TNW.**

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: **Jurisdictional Wetland 2 is separated from an offsite, contiguous wetland system by Zion Road, which appears to have been constructed through wetland, thus separating the two features. Based on a jurisdictional determination NWP-2007-428, the US EPA determined on February 25, 2008, that wetlands separated by an artificial barrier, which is a road/berm in this instance, does not sever the areas from functioning as one wetland. Therefore, Jurisdictional Wetland 2 is part of the offsite contiguous wetland system. The offsite contiguous wetland system has a direct surface water connection to Four Hole Swamp, the TNW .**

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

feature is offsite, it was observed on the northern portion of the review area at the project limits, as the tributary bank is the project limit line. The tributary was observed to have a bed and bank, OHWM, and was flowing during the time of the site visit. Due to tributary features such as sediment sorting, degree of scour, and sinuosity, as well as observable flow, the feature was determined to be a perennial tributary. Alligator Branch then discharges into Powder Horn Creek, a USGS blue line stream and perennial tributary, that then discharges into Four Hole Swamp, the TNW.
