- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Adjacent to, but not within, the project site is a wooded area with NWI mapped wetlands. After reviewing the provided site-pictures (dated July 24, 2017), Google Street-view imagery (dated February 2008 and May 2012), aerials dated 1999-2017, and undated LiDAR digital elevation model (DEM) data, it is clear that the project site and the immediately adjacent land within the scope of the proposed project, the demolition of the domicile, are not within this wooded area. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This 0.10 acre project site is located within a previously developed residential lot that currently houses a home and a small section of uplands around the domicile. Aerial imagery from 1999-2017, LiDAR aerial imagery, and recent site photos support that this project site is an upland residential lot with no aquatic resources within the project boundaries.

The Darlington west quadrangle USGS topographic map depicts the site as non-forested with no aquatic resources, blue line features, or wetland symbology within the project site. Darlington County soil survey, pg. 33, depicts one hydric soil within the project site, Goldsboro sandy loam (0-2% slopes) (GoA). National Wetland Inventory (NWI) maps depict about half of the site as palustrine forested needle-leaved evergreen wetland that is seasonally flooded and partially drained / ditched, the remainder of the land type is residential (U11). LiDAR Digital Elevation Model (DEM) aerial imagery depicts no significant elevation changes, ditching, or other features indicative of aquatic resources within the project site.

Adjacent to, but not within, the project site is a wooded area with NWI mapped wetlands. After reviewing the provided site-pictures (dated July 24, 2017), Google Street-view imagery (dated February 2008 and May 2012), aerials dated 1999-2017, and undated LiDAR digital elevation model (DEM) data, it is clear that the project site and the immediately adjacent land within the scope of the purposed project, the demolition of the domicile, are not within this wooded area. Furthermore, all land along the project fringes, and immediately adjacent to the project, appear to be within a maintained residential lawn that would not support the development of functioning wetlands and other aquatic resources

This 0.10 acre project site contains 0 acres/linear feet of jurisdictional resources. This site was assessed per the provided project area maps and on a single-basis form..
