Explain: **Five isolated wetlands, totaling 9.04 acres, were assessed within the review area and determined to be non-jurisdictional. The NWIs depict Non-jurisdictional Wetlands 4 and 5 as palustrine forested wetlands (PFO1/4C), and**

Non-jurisdictional Wetlands 8, 9, and 10 are depicted as palustrine scrub-shrub wetlands (PSS1Cd and PSS4Bd). According to the aerials and topographic map, no blue lines or potential linear features are present in or surrounding these isolated wetlands. The soil survey maps these wetlands as Eulonia and Blanton, which are not hydric soils. During the site visit, these wetlands were viewed and the boundary of each wetland was observed. These depressional wetlands are surrounded by non-hydric soils and no potential hydrological connection was observed for these wetlands. Therefore, these wetlands were determined to be isolated and non-jurisdictional.

These depressional wetlands exhibited hydric soils and indicators of hydrology, including saturated soils and water-stained leaves, which satisfies the criteria set forth in the 1987 Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement. These wetlands are forested with hydrophytic vegetation present. All water located within or draining toward these wetlands had no discernible or traceable outfall or connection to any WOUS. Additionally, these wetlands were found to be completely surrounded by uplands, which further disrupts any possible connection to any WOUS. Chemically, these wetlands do not affect any WOUS in the absorption/treatment of nutrients, runoff, or pollutants. Physically, the topographic locations of these wetlands are such that water is retained and eventually percolates through the soil to groundwater only, at an unknown depth, providing little if any stormwater attenuation. Biologically, the wetlands are not essential in providing organic carbon in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernible outfall, topography grades and lack of evidence of chemical, physical, or biological connection, these five wetlands were determined to be isolated, non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
