**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The area in review included 22.30 acres and contained no Waters of the U.S. or wetlands (isolated or adjacent). After a review of office resources and data supplied by the agent, all indicators onsite point to a well drained, upland site with little to no slope. The area in review is a portion of a golf course and Horry county NWI data depicts the majority of the site as U42P (upland planted pines) No portion of the site exhibited wetland hydrology as documented on the supplied delineation data.

Located onsite is a single upland excavated non-jurisdictional pond with no connection to WOUS or other jurisdictional resources (1.0 acres total).
