This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Jurisdictional Tributary 2: 264' + Jurisdictional Tributary 3: 429' + Jurisdictional Tributary 4: 165' = 4030'), are apparent on historical topographical maps and LiDAR imagery. The main branch of this feature is illustrated on USGS topographical maps as an aquatic feature (solid blue line feature). Geographically this feature is contained within an incised valley that terminates into the Black River. This feature receives storm-water via cross-surface sheet-flow from the landward onset of the feature near the western property boundary, and is tidally influenced at its termination point, where it drains into tidal wetlands along the Black River. While on-site a defined bed and banks, a sandy bottom with sediment sorting, sinuosity, and continuous flowing water throughout all four tributary branches were observed.

Data sources: Hydrologic Unit Code: Indian Hut Swamp – Black River (030402050906). USGS Topographic map depicts a forested site abutting the Black River; within the project site, multiple aquatic resources are illustrated, including: the Black Rivers bank, wetland symbology, and one solid blue line feature (depicting a perennial tributary feature). USDA / NRCS soil survey for Georgetown County depicts two soil types within the project site, including Lakeland fine sand (0-6% slopes) and Hobonny Muck. Hobonny muck is listed as hydric in the 2017 hydric soils list for Georgetown County. National wetlands inventory depict palustrine wetlands, as well as one linear feature (tributary) within the project site. All waters depicted on the NWI mapped wetlands approximately match the location of the on-site delineated resources. LiDAR digital elevation model imagery depicts the river basin for the Black River, as well as a geographical depression, indicative of a relatively permanent water. LiDAR approximately matches USGS topographic map.

Relatively Permanent Waters (RPWs) analysis: The tributary, and its three branches, 4030' total (Jurisdictional Tributary 1: 1172' + Jurisdictional Tributary 2: 264' + Jurisdictional Tributary 3: 429' + Jurisdictional Tributary 4: 165' = 4030'), are apparent on historical topographical maps and LiDAR imagery. The main branch of this feature is illustrated on USGS topographical maps as an aquatic feature (solid blue line feature). Geographically this feature is contained within an incised valley that terminates into the Black River. This feature receives storm-water via cross-surface sheet-flow from the landward onset of the feature near the western property boundary, and is tidally influenced at its termination point, where it drains into tidal wetlands along the Black River. While on-site a defined bed and banks, a sandy bottom with sediment sorting, sinuosity, and continuous flowing water throughout all four tributary branches were observed.

Jurisdictional resources within site: 2,052 linear feet of Black River High bank (HTL), 24.91 acres of wetlands (17.11 tidal; 7.80 non-tidal) and 4,030 linear feet of non-tidal tributaries.

This site was assessed on a single basis form, per the provided site maps.
